Bayou Valarie Booster Station Demo –The site has been cleared except for an AT&T box. There was a leak on the service link that Volute will address tomorrow.

On a motion by Blaine Mabile, seconded by Charles Brown and unanimously carried to authorize the General Manager to sign the Substantial Completion.

Plant Pump House Pump #3 Upgrade – The project is completed, and the Certificate of Substantial Completion has been recorded.

On a motion by Kenneth Dupaty, seconded by Adam Mayon and unanimously carried to pay invoice dated April 4, 2024 to Miller Engineering in the amount of \$108.15 (Recordation of Substantial Completion).

Plant #5 Addition Project (2022 Bond Project) – A revised scope has been developed to reduce costs. The plans will have to be revised.

Administrative Building/Board Meeting Room (2022 Bond Project) – The building phase is in progress. The sewer lift station has been installed.

On a motion by Blaine Mabile, seconded by Jerome Bougere and unanimously carried to pay Invoice #240305110 dated April 9, 2024 to Meyers Engineers & Architects, Ltd. in the amount of \$4,873.98 (25% Construction Administration).

On a motion by Kenneth Dupaty, seconded by Blaine Mabile and unanimously carried to pay Invoice #3 dated March 27, 2024 to DEL-CON LLC, in the amount of \$268,790.15.

Elevated Tower Rehabilitation Review (2022 Bond Project) – The Belle River tower is now complete. The Bayou L'Ourse tower will go through the disinfection phase tomorrow and possibly be back in service at the end of next week with a punch list.

On a motion by Blaine Mabile, seconded by Jerome Bougere and unanimously carried to pay Invoice #21255-P1-9 dated April 15, 2024 to High Tide Consultants, LLC in the amount of \$12,277.48 (3<sup>rd</sup> Party Inspection Fees).

On a motion by Blaine Mabile, seconded by Kenneth Dupaty and unanimously carried to pay Invoice #5 to Dixie Painting & Sandblasting, Inc., in the amount of \$151,945.47 (99% Complete).

On a motion by Kenneth Dupaty, seconded by Calvin Steward and unanimously carried to Authorize the General Manager to issue the Substantial Completion for Belle River and Bayou L'Ourse towers.

On a motion by Blaine Mabile, seconded by Travis Daigle and unanimously carried to Authorize the Board President to Sign Engineering Contracts with High Tide Consultants, LLC for Paincourtville and Pierre Part Tower Rehabilitation.

Hwy 402 Upgrade Project (Phase 1) – The plans are 90% complete and will be submitted to DOTD for permit. It will be submitted to DHH once the routing is completed.

On a motion by Travis Daigle, seconded by Calvin Steward and unanimously carried to pay Invoice #23269-2 to High Tide Consultants, LLC in the amount of \$19,610.00 (13.81% Engineering and 86.94% Survey Work).

Southall Street Waterline Upgrade Project – DHH approval has been received. The bidders will be invited once the specs are ready.
