On a motion by Scott Sternfels, seconded by Charles Brown and unanimously carried to approve the minutes of the July 22, 2024 Engineering Committee meeting.

Plant #5 Addition Bond Project (2022 Bond Project) - B.J. Francis informed the Board that the revised plans have been received.

Administrative Building/Board Meeting Room (2022 Bond Project) – B.J. Francis informed the Board that construction is still in progress.

On a motion by Scott Sternfels, seconded by Charles Brown and unanimously carried to pay invoice #7 dated August 7, 2024 to DEL-CON, LLC in the amount of \$241,537.50 (Project Management & Construction).

Elevated Tower Rehabilitation Review (2022 Bond Project) – Shane Guin gave updates. He informed the Board that the paperwork has been submitted to DHH. They are coordinating with the fire chief regarding the radio equipment located on the Pierre Part tower.

On a motion by Charles Brown, seconded by Scott Sternfels and unanimously carried to pay invoice #21255-P3-2 dated August 8, 2024 to High Tide Consultants, LLC in the amount of \$4,042.35 (15% Preliminary Design).

Hwy 402 Upgrade Project (Phase 1) – Shane Guin gave updates. He informed the Board that the approvals have been received from DHH and DOTD. They will advertise for bids on September 9th; open bids on October 9th with substantial completion by May 2025.

On a motion by Charles Brown, seconded by Scott Sternfels and unanimously carried to pay invoice #23269-5 dated August 19, 2024 to High Tide Consultants, LLC in the amount of \$11,077.35 (61% Design Engineering & Mileage).

Southall Street Waterline Upgrade Project – Shane Guin gave updates. He informed the Board that approval from DHH has been received and that the project will be moved to the other side of the street and the request for quotes will be sent out.

On a motion by Scott Sternfels, seconded by Charles Brown and unanimously carried to pay invoice #23283-3 dated August 20, 2024 to High Tide Consultants, LLC in the amount of \$2,924.50 (75% Design Engineering & Mileage).
