On a motion by Wayne Arboneaux, seconded by Charles Brown and unanimously carried to approve the minutes of the August 25, 2025 Engineering Committee meeting.

Plant #5 Addition Bond Project (2022 Bond Project) – Steve Breeding informed the Board that they are on schedule. They are hanging steel and pouring concrete. The raw water pump station building is complete.

On a motion by Charles Brown, seconded by Wayne Arboneaux and unanimously carried to pay invoice #18 dated August 31, 2025 to Shred-Kuyrkendall & Associates, Inc.in the amount of \$21,516.57 (21.56% Construction Phase and 151.5 Hours Resident Inspection).

On a motion by Wayne Arboneaux, seconded by Charles Brown and unanimously carried to pay invoice #5 dated August 31, 2025 to Pintail Contracting Services in the amount of \$795,750.69 (21.57% Complete).

On a motion by Charles Brown, seconded by Wayne Arboneaux and unanimously carried to pay invoice #921349 dated August 5, 2025 to Alpha Testing and Inspection, Inc. in the amount of \$760.00 (Concrete Curing and Testing, Transportation).

Administrative Building/Board Meeting Room (2022 Bond Project) – Shawn Woodward informed the Board that the project is 100% complete. There are a few punch list items and there will be a crew to do the final cleaning of the building.

Rue De Kajun Waterline Relocation for DOTD Bridge Upgrade Project – Landon Hebert informed the Board that they are dealing with DOTD issues with servitudes.

On a motion by Wayne Arboneaux, seconded by Charles Brown and unanimously carried to pay invoice #24304-4 dated September 15, 2025 to High Tide Consultants, LLC in the amount of \$685.00 (Engineering).
